**A RESOLUTION HONORING AND RECOGNIZING THE SERVICE OF RICHARD
BROOK TO THE BURLINGTON COUNTY MUNICIPAL
JOINT INSURANCE FUND**

WHEREAS, the Burlington County Municipal Joint Insurance Fund (hereinafter “BURLCO JIF”) is duly constituted as a Municipal Joint Insurance Fund pursuant to N.J.S.A. 40A:10-36 et seq.; and

WHEREAS, the Commissioners of the BURLCO JIF find it appropriate to recognize the service to the Fund of a Fund Commissioner of the Burlington County Municipal Joint Insurance Fund; and

WHEREAS, **Richard Brook**, Fund Commissioner for the Township of Florence, and in his capacity as aforesaid, has served as a dedicated and distinguished Commissioner of the BURLCO JIF, and the Fund is desirous of recognizing his tenure as a Fund Commissioner; and

WHEREAS, **Richard Brook**, has served as the Fund Commissioner for the Township of Florence since 1991 and has actively served, at various times during his 29 year tenure with the Fund, as Chair of the Coverage & Finance Committees and as a member of the Safety Committee; and

WHEREAS, in recognition of his hard work and dedication to the core principles of the Fund, the members of the BURLCO JIF unanimously voted **Richard Brook** as Chair of the Fund from 2002 through 2008; and

WHEREAS, when the Fund joined the Environmental Risk Management Joint Insurance Fund (EJIF) on January 1, 2006, and was in need of a liaison to represent the Fund’s interests, **Richard Brook** volunteered to serve in this capacity through 2015; and

WHEREAS, in recognition of his leadership skills and overall commitment to the success of the EJIF, **Richard Brook** was unanimously elected as Chair of the EJIF in 2012; and

WHEREAS, one of the most important commitments of the EJIF was to establish a Sustainable Energy Meeting (SEM) that would serve its members as a knowledge-based energy purchasing group designed to help New Jersey public entities initially reduce their energy costs and ultimately meet their social and regulatory obligations; and

WHEREAS, as a result of his desire and commitment, the SEM started operations in 2009 with **Richard Brook** serving as the Statewide Chair, a position he held until 2013; and

WHEREAS, the BURLCO JIF wishes to recognize **Richard Brook**, for his approach to decision-making; his careful attention to and his assistance in promulgating Fund policies and procedures; his determination to ensure that the Fund would operate in a consistent, orderly and fair manner; and above all, his unwavering dedication to achieving the ultimate goals of the Fund.

NOW, THEREFORE, BE IT PROCLAIMED, by the Commissioners of the Burlington County Municipal Joint Insurance Fund assembled in a public session on March 21, 2020, that this body does hereby honor and congratulate **Richard Brook** for his many years of unselfish and dedicated service as a Fund Commissioner; and

BE IT FURTHER PROCLAIMED that the members of the BURLCO JIF extend to **Richard Brook** their best wishes on the occasion of his retirement as a Fund Commissioner; and


BE IT FURTHER RESOLVED, that copies of this Resolution shall be provided to the Mayor and Council of the Township of Florence for their information and attention.
