**A RESOLUTION HONORING AND RECOGNIZING THE SERVICE OF JEFFREY
HATCHER TO THE BURLINGTON COUNTY MUNICIPAL

WHEREAS, the Burlington County Municipal Joint Insurance Fund (hereinafter "BURLCO JIF") is duly constituted as a Municipal Joint Insurance Fund pursuant to N.J.S.A. 40A:10-36 et seq.; and

WHEREAS, the Commissioners of the BURLCO JIF find it appropriate to recognize the service to the Fund of a Fund Commissioner of the Burlington County Municipal Joint Insurance Fund; and

WHEREAS, Jeffrey Hatcher, Fund Commissioner for the Township of Delran, and in his capacity as aforesaid, has served as a dedicated and distinguished Commissioner of the BURLCO JIF, and the Fund is desirous of recognizing his tenure as a Fund Commissioner; and

WHEREAS, Jeffrey Hatcher, has served as the Fund Commissioner for the Township of Delran since 1991 and has actively served, at various times during his 30 year tenure with the Fund, as Chair of the Finance Committee and as a member of the Coverage Committee; and

WHEREAS, in recognition of his hard work and dedication to the core principles of the Fund, the members of the BURLCO JIF unanimously voted **Jeffrey Hatcher** as a member of the Executive Committee for more than 20 years; and

WHEREAS, when the Fund was in need of a liaison to represent the Fund's interests at the Municipal Excess Liability Joint Insurance Fund (NJMEL), **Jeffrey Hatcher** volunteered to serve in this capacity for 8 years; and

WHEREAS, in recognition of his leadership skills and overall commitment to the success of the Municipal Excess Liability Joint Insurance Fund, **Jeffrey Hatcher** was unanimously elected as Chair of the NJMEL in 2009 and 2010; and

WHEREAS, the BURLCO JIF wishes to recognize **Jeffrey Hatcher**, for his approach to decision-making; his careful attention to and his assistance in promulgating Fund policies and procedures; his determination to ensure that the Fund would operate in a consistent, orderly and fair manner; and above all, his unwavering dedication to achieving the ultimate goals of the Fund.

NOW, THEREFORE, BE IT PROCLAIMED, by the Commissioners of the Burlington County Municipal Joint Insurance Fund assembled in a public session on December 21, 2021, that this body does hereby honor and congratulate **Jeffrey Hatcher** for his many years of unselfish and dedicated service as a Fund Commissioner; and

BE IT FURTHER RESOLVED, that copies of this Resolution shall be provided to the Mayor and Council of the Township of Delran for their information and attention.


