**A RESOLUTION HONORING AND RECOGNIZING THE SERVICE OF DAVID
MATCHETT TO THE BURLINGTON COUNTY
MUNICIPAL JOINT INSURANCE FUND**

WHEREAS, the Burlington County Municipal Joint Insurance Fund (hereinafter “BURLCO JIF”) is duly constituted as a Municipal Joint Insurance Fund pursuant to N.J.S.A. 40A:10-36 et seq.; and

WHEREAS, the Commissioners of the BURLCO JIF find it appropriate to recognize the service to the Fund of a Fund Commissioner of the Burlington County Municipal Joint Insurance Fund; and

WHEREAS, David Matchett, Fund Commissioner for the Township of Shamong, and in his capacity as aforesaid, has served as a dedicated and distinguished Commissioner of the BURLCO JIF, and the Fund is desirous of recognizing his tenure as a Fund Commissioner; and

WHEREAS, David Matchett, has served as the Fund Commissioner for the Township of Shamong since 1991 and has actively served, at various times during his 30 year tenure with the Fund, as served on the Coverage, Finance, Safety, New Member Review, and Strategic Planning Committee; and

WHEREAS, in recognition of his hard work and dedication to the core principles of the Fund, the members of the BURLCO JIF unanimously voted **David Matchett** as a member of the Executive Committee for more than 20 years; and

WHEREAS, when the Fund was in need of a liaison to represent the Fund’s interests at the Municipal Excess Liability Residual Claims Joint Insurance Fund (MEL RCF) in 1995, **David Matchett** volunteered to serve in this capacity; and

WHEREAS, in recognition of his leadership skills and overall commitment to the success of the Municipal Excess Liability Residual Claims Joint Insurance Fund, **David Matchett** was unanimously elected as Secretary of the MEL RCF from 1995 through 2006 and as Chair of the MEL RCF from 2007 through 2017; and

WHEREAS, the BURLCO JIF wishes to recognize **David Matchett**, for his approach to decision-making; his careful attention to and his assistance in promulgating Fund policies and procedures; his determination to ensure that the Fund would operate in a consistent, orderly and fair manner; and above all, his unwavering dedication to achieving the ultimate goals of the Fund.

NOW, THEREFORE, BE IT PROCLAIMED, by the Commissioners of the Burlington County Municipal Joint Insurance Fund assembled in a public session on January 18, 2022, that this body does hereby honor and congratulate **David Matchett** for his many years of unselfish and dedicated service as a Fund Commissioner; and


