**A RESOLUTION HONORING AND RECOGNIZING THE SERVICE OF GLENN
MCMAHON TO THE BURLINGTON COUNTY MUNICIPAL

WHEREAS, the Burlington County Municipal Joint Insurance Fund (hereinafter “BURLCO JIF”) is duly constituted as a Municipal Joint Insurance Fund pursuant to N.J.S.A. 40A:10-36 et seq.; and

WHEREAS, the Commissioners of the BURLCO JIF find it appropriate to recognize the service to the Fund of a Fund Commissioner of the Burlington County Municipal Joint Insurance Fund; and

WHEREAS, **Glenn McMahon**, Fund Commissioner for the Township of Chesterfield, and in his capacity as aforesaid, has served as a dedicated and distinguished Commissioner of the BURLCO JIF, and the Fund is desirous of recognizing his tenure as a Fund Commissioner; and

WHEREAS, **Glenn McMahon**, has served as the Fund Commissioner for the Township of Chesterfield since 2007; and

WHEREAS, during his tenure with the Fund, **Glenn McMahon** actively served as a member of the Coverage Committee for two years and as a member of the Strategic Planning Committee for more than a decade, a Committee he would Chair in 2019 and 2020; and

WHEREAS, in recognition of his hard work and dedication to the core principles of the Fund, the members of the BURLCO JIF unanimously voted **Glenn McMahon** as Secretary of the Fund in 2019 and 2020 and Chair of the Fund in 2021 and 2022; and

WHEREAS, the BURLCO JIF wishes to recognize **Glenn McMahon**, for his approach to decision-making; his careful attention to and his assistance in promulgating Fund policies and procedures; his determination to ensure that the Fund would operate in a consistent, orderly and fair manner; and above all, his unwavering dedication to achieving the ultimate goals of the Fund.

NOW, THEREFORE, BE IT PROCLAIMED, by the Commissioners of the Burlington County Municipal Joint Insurance Fund assembled in a public session on January 17, 2023, that this body does hereby honor and congratulate **Glenn McMahon** for his many years of unselfish and dedicated service as a Fund Commissioner; and


